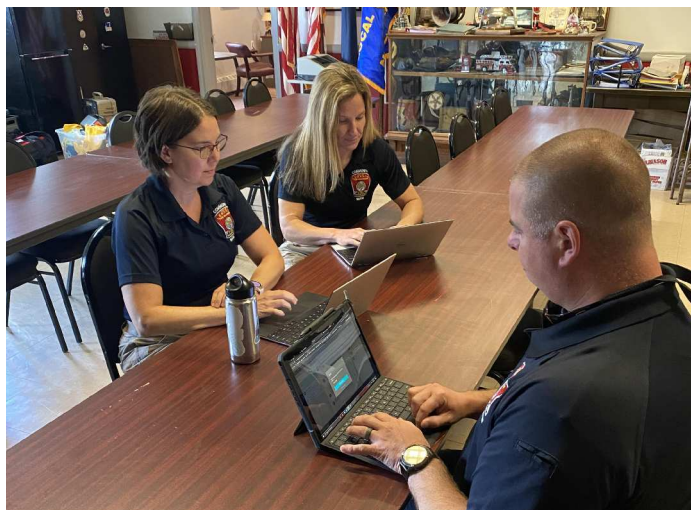
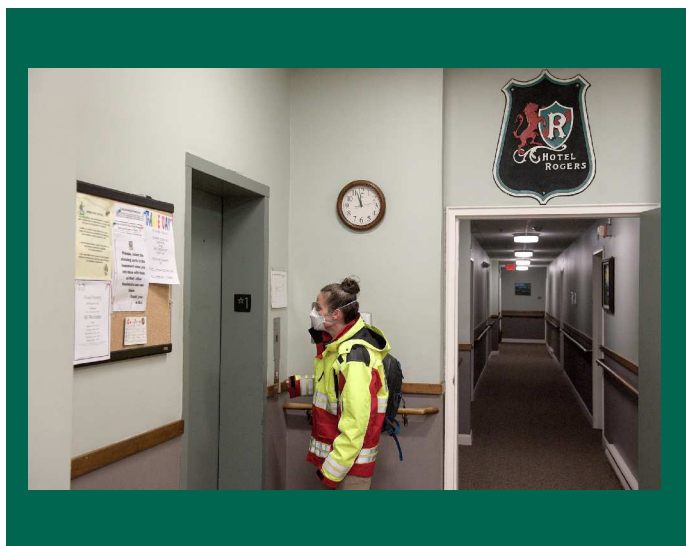


Mobile Integrated Health (MIH) January-June 2024 Semi-Annual Report

Program Overview

Lebanon Fire Department Mobile Integrated Health Program is a collaboration with Dartmouth Hitchcock Medical Center (DHMC), the Lebanon Fire Department and Lebanon Community Nurse programs.

This program operates under the medical direction and oversight of DHMC Emergency and Primary Care physicians, in collaboration with DHMC providers.

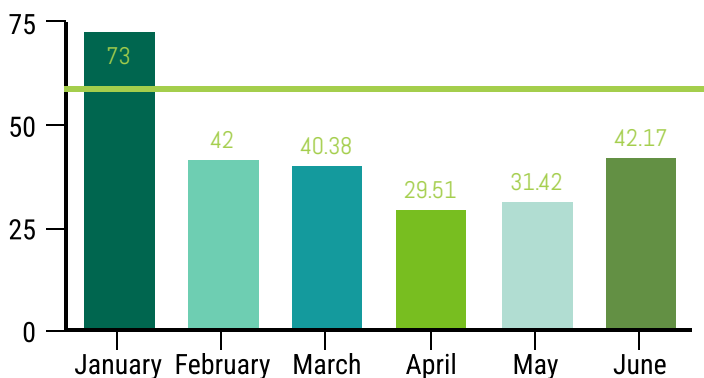

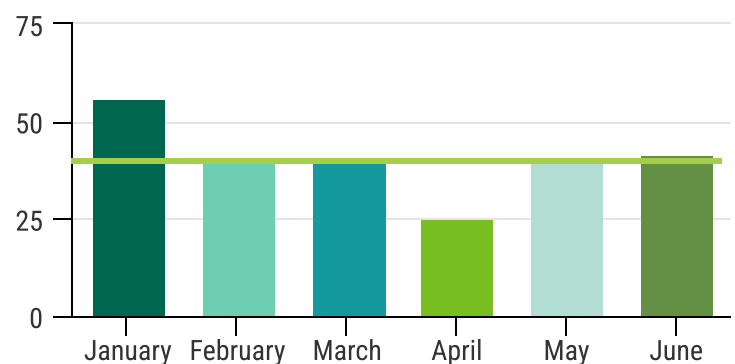
Patient Story

Kenny is a 38-year-old male from Vermont who has been unhoused for a very long time. He couldn't say when he last had stable and safe housing. He spent nights at the Lebanon Winter Shelter and a "friend in West Lebanon" has his insulin so he is known in Lebanon. He has a past medical history of substance use disorder, diabetes, anxiety, and multiple hospitalizations for cellulitis. He is very involved with a community harm reduction center and a request for wound care was made to Mobile Integrated Health (MIH) for Xylazine wounds. After three no shows for visits, he was seen 4 times (two with community nurses and community paramedic and two with just the community paramedic) for wound care. He had multiple Xylazine wounds on his body and trench foot from wearing the same socks and boots. After wound care at the first visit, he was given a clean package of socks and a bag of wound care supplies to continue treating the wounds between visits. Most of his wounds, including his feet, had resolved at later visits but there were a few deeper wounds. After one month of weekly visits, he was hospitalized for an infection in his tendon that was unable to be treated in the community setting. The wound care he received from MIH prevented multiple infections and potential amputation of toes. During the Lebanon Pop Up clinic for unhoused individuals, MIH, Lebanon Health and Human Services and the harm reduction organization involved, were able to coordinate to get him the resources he needs upon discharge from the hospital.

2024 Grantham Community Nurse Hours

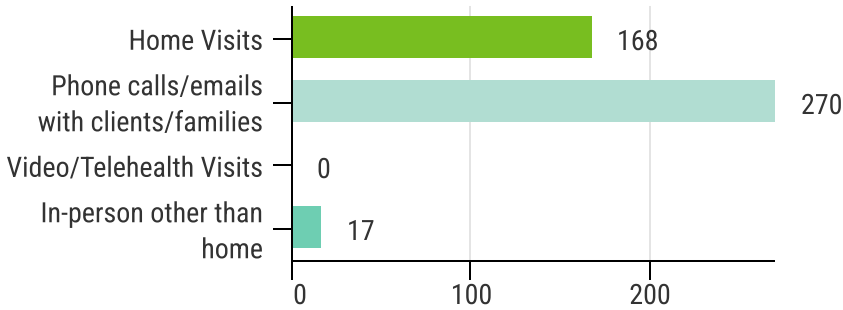


2024 Enfield Mobile Integrated Health Hours



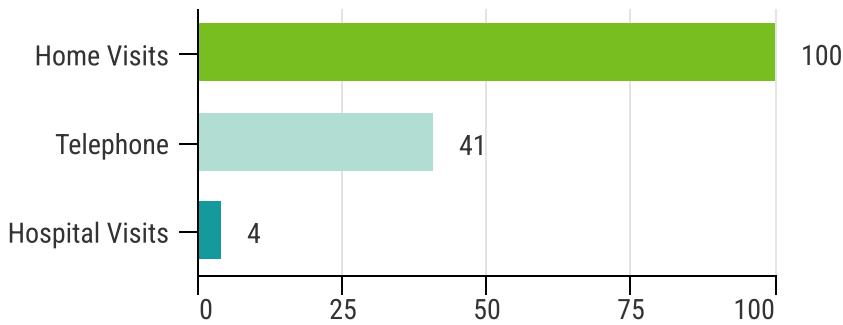

Community Nurse Encounter Types 1/1/24-6/30/2024



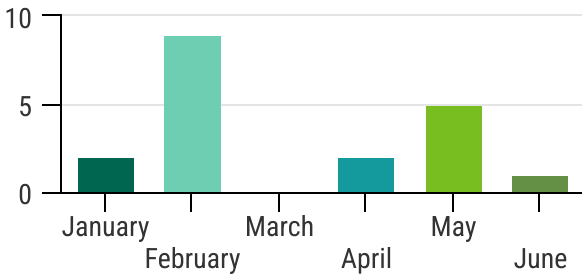
